Beer Permit Application Instructions

DEADLINE FOR FILING APPLICATION

Applicant(s) must file application and all other required forms by the following date:

BEER BOARD MEETING DATE

Applicant(s) must appear, in person, before the Rutherford County Beer Board, in the Office of the Rutherford County Clerk located in Suite 121 at 319 North Maple Street in Murfreesboro, Tennessee, at 6:00 p.m. on the following date:

COMPLETION OF COUNTY BEER PERMIT APPLICATION

- ◆ The County Beer Permit Application must be typed or printed in black ink only.
- ◆ The County Beer Permit must be applied for in the name of the Owner(s) of the proposed beer establishment unless a Corporation owns the business. If a Corporation operates the new business, then the County Beer Permit must be applied for in the name of the Corporation.
- ◆ The Owner(s) must sign the County Beer Permit Application before a Notary Public.
- ◆ The Owner(s) must comply with the following distance and survey requirements:
 1. The Beer Establishment must be at least 600 feet from the nearest Church, School or Public Gathering Place.
 2. Owner(s) are required to file a plat survey certified by a licensed surveyor, showing the distance from the nearest Church, School or Public Gathering Place, in the Office of the Rutherford County Clerk for any of the following reasons:
 - a. The Beer Establishment is located in a newly constructed building.
 - b. The former Beer Establishment did not obtain a valid Rutherford County Beer Permit.
 - c. The former Beer Establishment obtained a valid Rutherford County Beer Permit but has been closed for more than six (6) months.

The distance must be measured by a straight-line method rather than by street or property lines from the nearest point of the beer establishment building to the nearest point of the building of the nearest Church, School or Public Gathering Place. If a survey is required, the owner(s) must file a certified plat survey, a signed "Letter of Certification" from the licensed surveyor, and the County Beer Application in the Office of the Rutherford County Clerk by the deadline date. A "Letter of Certification" form is attached to this application.

- ◆ The Applicant is required to file the County Beer Permit Application and all other required documents in this office with an application fee of **\$250.00** made payable to the *Rutherford County Clerk* along with a separate check made payable to *Main Street Media* for the public notice, that is required to be published, in the amount of **\$70.00** by the deadline date. (Please note that the fees are non-refundable).

COMPLETION OF BUILDING CODES, PLANNING & ZONING REQUIREMENTS

The Applicant is required to obtain a "Certificate of Occupancy" prior to the issuance of a Rutherford County Beer Permit and attach a copy of said "Certificate of Occupancy" with the Application before the deadline date. A "Certificate of Occupancy" form is attached to this application. To obtain said Certificate, schedule inspections and secure signed approval from the following Departments:

◆ BUILDING/MECHANICAL AND SIGN INSPECTION

The Applicant should contact Building Codes at 615-898-7734 to set up an appointment for both inspections and signed approval. The Building Codes Department is located at One Public Square South, Room 101 in Murfreesboro, Tennessee.

◆ STATE ELECTRICAL INSPECTION

The Applicant should contact the State Electrical Inspection Office at 896-6117 to set up an appointment for inspection and signed approval. The State Electrical Inspection Office is located at One Public Square South in Murfreesboro, Tennessee. Applicant must give State Electrical Inspection Office at least one week notice before inspection can be scheduled.

◆ STATE ENVIRONMENTAL (SEPTIC) INSPECTION

The Applicant should contact the State Environmental (Septic) Inspection Office at 898-7891 to set up an appointment for inspection and signed approval. The State Environmental (Septic) Inspection Office is located at One Public Square South in Murfreesboro, Tennessee. Please allow 2 to 3 weeks for the inspection process.

◆ SITE PLAN REVIEW AND ZONING APPROVAL

The Applicant should contact the Planning Department at 615-898-7730 to set up an appointment for both inspections and signed approval. The Planning Office is located at One Public Square South in Murfreesboro, Tennessee.

COUNTY BUSINESS LICENSE & STATE DRIVER'S LICENSE REQUIREMENT

IMPORTANT NOTICE! The applicant is required to have a county business license before a beer permit is issued. The business license application, which is attached to this application, must be turned in with the \$15.00 fee before the meeting and a copy of the license must be kept in the applicant's file. A copy of each owner(s) & manager(s) state issued driver's license must be attached to the beer permit application.

ANNUAL PRIVILEGE TAX

The Applicant will be required to pay an annual Beer Privilege Tax of \$100.00 between January 2nd and January 31st of each year. If granted a Beer Permit, the Applicant will be required to pay the following pro-rated portion of the Beer Privilege tax to the Rutherford County Clerk: \$_____.

SALES TAX REQUIREMENT

The Applicant is required to file a copy of the State Sales Tax Registration Certificate in the Office of the Rutherford County Clerk within ten (10) days following the issuance of the Beer Permit.

EXPIRATION OF RUTHERFORD COUNTY BEER PERMIT

T. C. A. 57-5-103(a)(6) states: A permit holder must return a permit to the county or the city that issued it within fifteen (15) days of termination of the business, change in ownership, relocation of the business or change of the business's name; provided, that notwithstanding the failure to return a beer permit, a permit shall expire on termination of the business, change in ownership, relocation of the business or change of the business's name.

CRIMINAL CHECKS ON EMPLOYEES OF BEER ESTABLISHMENTS

IN ORDER TO RECEIVE A PERMIT, AN APPLICANT MUST ESTABLISH THAT:

Tennessee Code Annotated 57-5-105(a)(4)... "No person employed by the applicant in such distribution or sale has been convicted of any violation of the laws against possession, sale, manufacture, or transportation of beer or other alcoholic beverages or any crime involving moral turpitude within the past ten (10) years".

Tennessee Code Annotated 57-5-105(a)(3)... "No person, firm, joint-stock company, syndicate or association having at least a five (5%) percent interest in the beer establishment nor any person to be employed in the distribution or sale of beer be convicted of any violation of the laws against possession, sale, manufacture, or transportation of beer or other alcoholic beverages or any crime involving moral turpitude within the past ten (10) years".

1. Select the classification under which your dominant business activity falls. "Dominant business activity" means the business activity that is the major and principal source of taxable gross sales of the business. If you need assistance in determining the appropriate business tax classification, please ask your county clerk or the designated city business tax official. You may also wish to refer to the document "Determining Your Business Tax Classification," which is available at tn.gov/revenue. Enter the month on which the taxpayer's fiscal year ends.

Entities having less than \$10,000 in annual gross receipts may either select the option for "Minimal Activity License" or register for a regular business license in the appropriate business classification. Minimal Activity Licenses are valid for only the fiscal year selected. Each year in which the taxpayer will have less than \$10,000 in annual gross receipts, a new Minimal Activity License must be obtained.

2. Select the reason for which the application is being filed - new business, additional location, or the purchase of an existing business.
3. Enter the date on which the applicant began or will begin conducting business activities at the location for which registration is being made.
4. Enter the name and exact location address of the business being registered. Include the business name, street address, city, state, and zip code.
5. Enter the mailing address of the business being registered. Enter the legal name (if different from location name), street address or post office box number, city, state, and zip code. If the legal name and mailing address are identical to the information in Item 4, leave Item 5 blank.
6. Enter the name of the county in which the business is located. Indicate whether the business is located within the limits of a city in the county. If the business is located within the limits of a city, enter the name of the city. **Note:** A business located within the limits of a city may have a business tax obligation for both the county and the city. If so, the business must obtain a business license from both the county and the city.
7. Enter the telephone number and, if applicable, the fax number of the business being registered.
8. Enter the name of a contact person for the business being registered. Enter the contact person's email address.
9. Enter the Federal Employer's Identification Number (FEIN) of the business being registered. If the business has applied for but not received an FEIN, so indicate. If no FEIN is required, so indicate.
10. If the business being registered currently has a sales and use tax account with the Tennessee Department of Revenue, enter the sales and use tax account number. If the business has applied for but not received a sales and use tax account number, so indicate. If no sales or use tax account number is required, so indicate.
11. Select the legal structure type of the business being registered.
12. Enter the Tennessee Secretary of State identification number of the business being registered, if applicable.
13. Enter a description of the business activities being performed by the business at the location being registered. Indicate the main products and services sold at this business location. Please be as detailed as possible.
