1.	Fees:	Duplicate Title			
		(Additional county fees may apply)			

- 2. If a lien exists in the records of the Vehicle Services Division, a duplicate title can only be issued to the lienholder. When a lien has been discharged, the owner may apply for a duplicate title, which will be mailed to the owner's address as shown on the application. If the owner has proof of the discharge, it should accompany the owner's request for a duplicate title.
- 3. The completed application for a duplicate title should be signed and submitted to the County Clerk with supporting documentation, when applicable.
