AS OF JULY 1, 2024

Unless otherwise specified, fees in civil cases should be paid in advance. Cost bonds allowed when indicated.

Warrants served by a Private Process Company require **NO OFFICER'S FEE**.

New Detainer and Civil Warrants filing fee is \$208.50. The total cost will depend on the service method you use.

WARRANTS SERVED OUTSIDE RUTHERFORD COUNTY REQUIRE TWO (2) SEPARATE CHECKS. One check is to the Circuit Court Clerk of Rutherford County for a total amount of \$208.50 and the other check made payable to the Sheriff of said County for \$52.00. Non-Attorney payments for service must be cashiers check or money order.

All post judgement **ORDERS** and **MOTIONS** are \$25.00.

Please note there is an additional **NON-REFUNDABLE** processing fee for credit or debit card transactions.
