The Planning Commission has two regularly scheduled meetings each month: the second Monday at 6:00 PM and the fourth Monday at 9:00 AM unless otherwise shown below. Rezoning applications are heard at the second Monday meeting and then will continue to the Board of Commissioners for a final decision. Subdivision plats and site plans are usually considered at the fourth Monday meeting.
